Application for Scholarship
2024-2025

Southern California Children's Chorus was founded in 1996 as a 501c3 nonprofit organization whose mission is "*enhancing children's lives through distinguished choral music education and world-class performance.*" SCCC is tuition-based and is dedicated to making its programs available to children from all economic backgrounds, providing scholarships and other forms of assistance to families in need. Striving to make membership as affordable as possible, the SCCC engages in an array of fundraising activities, deriving the significant portion of its budget not covered by tuition from tax-deductible contributions from the community as well as support from grant-making organizations.

The fixed dollar amount in the SCCC scholarship fund will be disbursed to those who have applied by the deadline and to those demonstrating the greatest financial need.

Choristers receiving other financial resources to assist in paying tuition will not be considered for SCCC scholarships as we have a limited amount of scholarship funds.

To be considered for a scholarship, applicants must submit the following by the deadline:

- **Scholarship Application.**
- **Signed Scholarship Contract** – Acknowledges their responsibilities as chorus members and agreeing that early withdrawal from SCCC may lead to revocation of the scholarship award.
- **Copy of the First page of most recent Federal Income Tax return or similar government documentation showing gross income and number in the household.**
- **Non-refundable amount equal to 10% of tuition. The remaining amount owed will be determined by the scholarship committee.**

Note: Applications received after the deadline *may* not be considered. The Scholarship Committee will review your request and you will be notified of your scholarship amount by mail as soon as possible. A new application with supporting documents must be submitted each year. Awards may vary from year to year based on the availability of funds, regardless of past awards.
